



**“JACKPOT WINNER DRAWINGS & PARTY”
OFFICIAL RULES**

1. **Eligibility:** This drawing is open to all active members of the Finger Lakes Casino & Racetrack Player Extras Club, who are 18 years old or older, and who abide by the rules and regulations of the Player Extras Club. Employees of Finger Lakes Casino & Racetrack; its subsidiaries and affiliates; people key licensed by the New York State Division of the Lottery; people licensed by the NY State Racing & Wagering Board as on-the-grounds employees; vendors directly associated with this contest, their subsidiaries, affiliates and agencies; and any immediate family members residing in the same household of any of the foregoing individuals are ineligible to participate in the program. Any licensee, registrant, contractor, subcontractor, consultant, officer; or employee of a contractor, subcontractor, licensee, registrant or consultant, that is directly involved in the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state and local rules and regulations apply. Void where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules.
2. **Sponsor:** (as defined below), Finger Lakes Casino & Racetrack, their respective affiliates, subsidiaries, parent corporations, and their respective officers, directors, shareholders, employees and agents are not responsible for any incorrect or inaccurate entry information; human error; technical malfunctions; failures, omission, interruption, deletion, or defect of any telephone network, computer online system, computer equipment, servers, providers, software or satellite transmission, including any injury or damage to participant or any other person relating to or resulting from participation in this program. Neither Finger Lakes Casino & Racetrack, nor any of the aforementioned are responsible for theft, tampering, destruction, or unauthorized access to, or alteration of applications; data processing that is processed late, incorrectly or is incomplete or lost due to computer or electronic malfunction; printing or other errors; or any combination thereof. False and/or deceptive entries or acts shall render entrants ineligible.
3. **Contest Period:** Each Calendar Month in 2012 represents a different eligibility period. A Jackpot Winners Bonus Drawing, Jackpot Winners Party and Jackpot Winners Free Play Drawing occur on the first Tuesday of the following month (except in cases during which it falls on a holiday and the drawing would be held on the first Wednesday).
4. **Method of Entry:** Player Extras Members who win a jackpot of \$600 or more during any month in the contest period and present their Jackpot Winner Slip to Player Extras will receive 125 points added into their Player Extras account for each jackpot won. The Cashier's Cage will issue a Jackpot Winner Slip to any patron presenting a limited voucher of \$600 or over. No duplicates, reproductions or facsimiles will be accepted. A valid photo ID must also be presented to a Player Extras Club Representative to receive entries.

Jackpot Winners Bonus Drawing: On the first Tuesday of the following month, jackpot winners will be automatically entered into the Jackpot Winners Bonus Drawing. Only Jackpot Winners are eligible for the drawing. To activate their entries and become eligible for the drawing, jackpot winners must play with their own Player Extras Card inserted into any video gaming machine between 9am-8pm on the day of the Jackpot Winners Bonus Drawing.

Jackpot Winners Party: On the first Tuesday of the following month, jackpot winners will be invited to attend a Jackpot Winners Party from 5pm-9pm at Seven's Sports Bar and receive a designated free play amount. Jackpot winners may bring one guest to accompany them to

the party, and the guest may also receive a designated free play amount. Jackpot winners and their guests must be Player Extras Members to receive free play vouchers. Limit one free play voucher per Member. Jackpot winners may not receive an additional free play voucher by accompanying another jackpot winner as their guest.

Jackpot Winners Free Play Drawing: On the first Tuesday of the following month, jackpot winners who check in at the Player Extras Club between 3-9pm will receive one entry to place in a barrel at Seven's Sports Bar for the Jackpot Winners Free Play Drawing. There will be twenty (20) random drawings at Seven's between 5pm-9pm for free play prizes. Only Jackpot Winners are eligible for the drawings. Winner must be present within five minutes of their name being called, or an alternate winner will be drawn. Management will determine winners' verification and Player Extras Club membership.

- Prizes:** Jackpot Winners Bonus Drawing: One (1) winner will be selected at random at 9pm on the first Tuesday of each month, based on the previous month's eligible entries, to win \$1,000 cash if present. Winner need not be present at drawing to win but if the winner is not present within five minutes of their name being called the prize is \$500 cash. The drawing will be conducted using the Electronic Quickdraw module of the Casino Marketplace player tracking system. All eligible entries are placed into a pool on the date of the drawing, and one name will be randomly selected via the Quickdraw module. A final report illustrating all activity with the Electronic Quickdraw will be printed and kept on file in-house.

Jackpot Winners Party: Any jackpot winner who checks in at the Player Extras Club may receive a designated free play amount based on ADT play levels from the last 3 months. Free Play amounts are \$15 Free Play and \$10 Free Play. Jackpot winners may bring one guest, and the guest also receives \$10 Free Play.

Jackpot Winners Free Play Drawing: There will be twenty (20) random drawings at Seven's between 5pm-9pm for \$50 in free play.

- Prize Acceptance:** All costs/expenses incurred in accordance with the prize awarded (if applicable) are the responsibility of the winner to pay. Winner is responsible for all sales and income taxes. By accepting their prize, winners acknowledge any and all restrictions, expiration dates and liabilities. If winner does not claim prize within 60 days of drawing, an alternate winner will be selected.
