 Distance for all three races: Six Furlongs

**REGULAR CLOSING: December 31, 2018 - \$25 nomination fee** (Covers two races: Fillies – New York Breeders' Futurity & Lady Finger; Colts – New York Breeders' Futurity & Aspirant)

**LATE CLOSING: April 1, 2019 - \$150 nomination fee** (Covers two races: Fillies – New York Breeders' Futurity & Lady Finger; Colts – New York Breeders' Futurity & Aspirant)

### NO REFUNDS – NO SUPPLEMENTS

#### 2<sup>nd</sup> Payment: May 31, 2019

Payments must be postmarked on or before 5/31/19 to maintain eligibility. Payments postmarked after that date will be returned and eligibility forfeited.

**\$250 New York Breeders' Futurity and \$175 Lady Finger (fillies) or \$175 Aspirant (colts). \$425 to maintain eligibility for both races.**

#### 3<sup>rd</sup> Payment – July 31, 2019

Payments must be postmarked on or before 7/31/19 to maintain eligibility. Payments postmarked after that date will be returned and eligibility forfeited.

**\$400 New York Breeders' Futurity and \$250 Lady Finger (fillies) or \$250 Aspirant (colts). \$650 to maintain eligibility for both races.**

FOR TWO YEAR OLDS (FOALS OF 2017), foaled in New York State and Approved by the New York State-Bred Registry. No supplementary nominations. By subscription of \$25 each if made on or before December 31, 2018 or \$150 each if made after December 31, 2018 and on or before April 1, 2019. The nomination fee to cover two races: For Fillies - The Lady Finger and The New York Breeders' Futurity; For Colts & Geldings - The Aspirant and the New York Breeders' Futurity. Finger Lakes Racing Association, Inc. to pay 100% of the purse for the Lady Finger, The Aspirant and The New York Breeders' Futurity. An administrative fee of 5% will be deducted from all payments. The added monies and all fees to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 2% to fifth and 1% to sixth, seventh and eighth.
