Monday 4/18/16 second Race the Stewards posted an Inquiry and Jockey Joel Sone rider of "Approval" (#6) claimed foul against (#4) "Riveressed" ridden by Jockey Harry Hernandez. During the run down the stretch "Riveressed" drifted out and interfered with "Approval". The Stewards disqualified "Reveressed" from first position and the horse was placed second.

A review of the video of the race was held on Saturday April 23 with the interested riders and Jockey Harry Hernandez was held blamless.

The Stewards held a Review of the 3rd. race from Nov. 29.2016 the following day. Present at the movies was jockey Carlos D. Camilo rider of "Darn That Trip" (#1).
