Week 4/26-5/1

Week 5/3 – 5/8

May 3, 2021 – Race #3

Jockey's objection by the rider of #2 "San Juan Diego" (Michael A. Davila, Jr) against #1 "Schwarbertown" (Joel Cruz) in the vicinity of the ¼ pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 1.2.6.5

May 3, 2021 – Race #4

Stewards' inquiry into the start of the race regarding #2 "Saratoga Yogi". The horse reared at start and refused. After reviewing the video the stewards determined the horse caused its own issues leaving the starting gate.

May 5, 2021 – Race #8

Stewards' inquiry and jockey's objection by the rider of #4 "Bellamy's Treasure" (Luis Perez) against #5 "A Huge Checkpoint" (#Joel Cruz) in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 5.4.1.7

May 25, 2021 – Race #5

Jockey's objection by the rider of #6 "Blood Man" (Luis Perez) against #2 "Florida Endeavour" (Jose Baez) at the top of the stretch. Jockey Luis Perez stated his horse may have been hit by the crop of Jockey Jose Baez. After reviewing the video and speaking to the riders involved, the stewards determined there was no video evidence to support if this incident occurred. The stewards made the race official as is. Final order of finish 2.6.3.1

Week 5/31 – 6/4

May 31, 2021 – Race #1

Jockey's objection by the rider of #3 "Yes Your Honor" (Jacqueline Davis) against #2 "Miss Amendment" (Steven Fret) in the vicinity of the 3/8^{ths} pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 2.3.6.1

May 31, 2021 – Race #5

Stewards' inquiry and jockey's objection by the rider of #1 "Mr. Mims" (Andre Worrie) against #4 "Papa Tom B" (Oscar Gomez) in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 4.1.5.3

June 16, 2021 – Race #1

Jockey's objection by the rider of #4 "Smart Tee" (Carlos D. Camilo) against #5 "You've Got Male" (John Davila, Jr.) in the vicinity of the ¾ pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 5.1A.3.2

Week 6/28 - 7/3

June 29, 2021 – Race #2

Stewards' inquiry and jockey's objection by the riders of #2 "Duck Pond Road" (Nazario Alvarado) and #6 "Construct" (Jacqueline Davis) against #4 "Guerreron" (Carlos D. Camilo) for interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #4 "Guerreron" from 1st position and placed that horse 3rd behind #2 "Duck Pond Road" New order of finish 6.2.4.1

June 29, 2021 – Race #5

Stewards' inquiry into the stretch run regarding #1a "Irish Valor" (Luis Perez), #2 "What R U Doing Now" (Harry Hernandez) and #3 "Turco Bravo" (Andre Worrie). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 4.1A.2.3

June 30, 2021 – Race #2

Stewards' inquiry into the start of the race regarding #5 "Munsoor" (Harry Hernandez). After reviewing the video the stewards determined the horse's chances were compromised at the start and declared the horse a non-starter for betting purposes.

Week 7/5 – 7/10

July 6, 2021 – Race #3

Jockey's objection by the rider of #4 "Sleepy Joe" (Emmanuel DeDiego) against #5 "Storm Afleet" (Jacqueline Davis) in the vicinity of the ¼ pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 5.6.4.3

Week 7/12 – 7/17

July 14, 2021 – Race #5

Stewards' inquiry and jockey's objection by the rider of #6 "Single Verse" (Kevin Navarro) against #4 "A Dab Will Do" (Oscar Gomez) for interference in the stretch. After reviewing the video and speaking to the riders involved the stewards determined there was interference in the stretch and disqualified #4 "A Dab Will Do" from 3rd position and placed the horse 4th behind #6 "Single Verse" New order of finish 1.3.6.4

July 14, 2021 – Race #7

Jockey's objection by the rider #1 "Irish Valor" (Luis Perez) against #2 "Our Caravan" (Andre Worrie) going into the first turn. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 2.1.8.6

Week 7/19 – 7/24

July 20, 2021 – Race #8

Stewards' inquiry and jockey's objection by the rider of #1 "Stone Heart" (Luis Perez) against #8 "Corporate Raider" (Michael Davila, Jr.) for interference in the stretch. After reviewing the video and speaking to the rider involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 3.8.1.4

July 21, 2021 – Race #6

Stewards' inquiry into the stretch run for possible interference in the stretch involving #4 "Papa Tom B" (Oscar Gomez) and #5 "Fitzpatrick" (Kevin Navarro). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 4.5.2.3

Week 7/26 – 7/31

July 26, 2021 – Race #3

Stewards' inquiry in the stretch run involving #1 "Classy Papa" (Jose Baez), #3 "Lightning Rob" (Luis Perez) and #6 "Armando's Team" (Kevin Navarro). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 3.6.1.2

July 28, 2021 – Race #9

Stewards' inquiry in the stretch run involving #3 "Throwing Stones" (Andre Worrie) and #6 "Trivia" (Jose Baez). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 2.3.6.4

August 10, 2021 – Race #8

Stewards' inquiry into the start of the race regarding #4 "Crossing Alaska" (Jose Baez). After reviewing the video the stewards determined the horse caused its own issues leaving the starting gate. Race official as is 3.7.9.8

August 16, 2021 – Race #4

Stewards' inquiry into the stretch run for possible interference by the #1 "Our Caravan" (Andre Worrie) against #4 "Internet of Things" (Kevin Navarro). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 1.4.7.3

August 30, 2021 – Race #3

Stewards' inquiry and jockey's objection by the rider of #5 "Isaiah Isaiah" (Jacqueline Davis) against #1 "Candyrock" (Nazario Alvarado) for interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident was caused by #3 "Harrison Knows" (Luis Perez) who finished behind #4 "Isaiah Isaiah" and made the race official as is. Final order of finish 1.4.5.2

August 31, 2021 – Race #2

Stewards' inquiry and jockey's objection by the rider of #2 "Honorable Avenue" (John Davila, Jr) against #5 "Tapit Happy John" (Luis Perez). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 1.5.2.4

August 31, 2021 – Race #7

Stewards' inquiry into the start of the race. #1 "Silver Banshee" (Kevin Navarro) stumbled at the start and unseated the rider. The race was made official as is. 2.5.3.7

Week 9/6 – 9/11

September 7, 2021 – Race #3

Stewards' inquiry into the stretch run involving #3 "Stormy New York" (Jeremias Flores), #5 "Financial Draw" (Jacqueline Davis) and #6 "Liams Majesty" (Jose Baez). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 5.3.6.1

September 7, 2021 – Race #6

Stewards' inquiry into the start of the race. #7 "Boomkittybyebye" (John Davila, Jr) stumbled at the start unseating the rider. The race was made official as is. 5.4.8.3

Week 9/13 – 9/18

September 13, 2021 – Race #6

Jockey's objection by the rider of #3 "Pape Tom B" (Oscar Gomez) against #1 "Fitzpatrick" (Kevin Navarro) and #4 "Nueva York" (Jose Baez) in the vicinity of the 5/16th pole. After reviewing the video and speaking to the riders involved the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 4.1.2.5

Week 9/20 – 9/25

September 20, 2021 – Race #1

Steward's inquiry for possible interference in the vicinity of the 1/16th pole involving #1 "Herecomesthejudge" (Andre Worrie) and #4 "Little Maddy Brown" (Jose Baez). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 3.4.1.2

September 21, 2021 – Race #5

Stewards' inquiry into the stretch run for possible interference involving #6 "Katies Courage" (Neftali Perez) and #7 "Parlapiano" (Carlos Camilo). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 3.1A.6.7

September 22, 2021 – Race #4

Stewards' inquiry and jockey's objection by the rider of #8 "Pretty Doctor" (Rudy Ignacio) against #3 "Quaysadilla" (Luis Perez) for interference in the stretch. After reviewing the video and speaking to the riders involved the stewards determined the incident did affect the outcome of the race and disqualified #3 "Quaysadilla" from 3rd position and placed that horse 5th behind #8 "Pretty Doctor". New order of finish 7.6.1A.8.3

September 29, 2021 – Race #2

Stewards' inquiry into the start of the race. #2 "Benny and Alex" lost rider at start. After reviewing the video the stewards made the race official as is. 5.4.1.7

Final order of finish 6.2.1A.1.4
