Week 4/25 – 4/30

Week 5/2 – 5/6

May 2, 2022 – Race 3

Stewards inquiry involving #1 “Get Your Gold” (Jockey Emanuel De Diego) and #3 “Daredevil Bull” (Andre Worrie) at the top of the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 3.1.2.4

Week 5/9 – 5/14

May 11, 2022 – Race 4

Jockey’s objection by the #4 “Racing Queen” (Jacqueline Davis) against #5 “Miss Pab” (John Davila) and #7 “All About Bella” (Joel Cruz) in the vicinity of the ¼ pole. A second jockey’s objection was claimed by #1 “Sweet Sugar Baby” (Andre Worrie) against #7 “All About Bella” (Joel Cruz) in the vicinity of the ¼ pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 5.7.6.1

Week 5/16 – 5/21

May 16, 2022 – Race 8

Jockey’s objection by the #1 “Another Image” (Emanuel De Diego) against #2 “Prairie Tales” (Andre Worrie) in the vicinity of the 9/16th pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 2.8.9.4

Week 5/23 – 5/28

May 24, 2022 – Race 1

Stewards inquiry into the stretch run, involving #2 “Shesascoldasice” (Keiber Coa) and #5 “Iova” (Joel Cruz). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 2.5.3.1

May 24, 2022 – Race 6

Stewards inquiry and jockey’s objection by the #2 “Betty’s Smile” (Jacqueline Davis) against #3 “It Can” (Joel Cruz) for alleged interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #3 “It Can” from 1st position and was placed 3rd behind #2 “Betty’s Smile.” New order of finish 6.2.3.4

Week 5/30 – 6/4

May 31, 2022 – Race 7

Stewards inquiry and jockey’s objection by the #5 “Noble Endeavor” (Jeremias Flores) against #4 “Double Vision” (Kevin Navarro) for alleged interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined #4 “Double Vision” drifted out multiple times interfering with #5 “Noble Endeavor”, warranting a disqualification from 1st position and was placed 2nd behind #5 “Noble Endeavor.” New order of finish 5.4.3.1

Week 6/6 – 6/11

June 6, 2022 – Race 1

Stewards inquiry into the stretch run, involving #4 “Miami Chrome” (Carlos Camilo) and #6 “Nutsie” (Steven Fret). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 4.6.2.3

June 6, 2022 – Race 4

Stewards inquiry into the start of the race, involving #1 “Great Grand Son” (Nazario Alvarado). After reviewing the video, the stewards determined that the horse caused its own issues after the break. Race made official as is. 5.6.2.3

Week 6/13 – 6/18

June 13, 2022 – Race 2

Stewards inquiry into an incident in the vicinity of the $\frac{3}{4}$ pole. #3 “Tuxedo Lemon” unseated jockey Michael Davila, Jr. After reviewing the video, the stewards determined that #4 “Smart Broad” (Jeremias Flores) drifted out, interfering with #3 “Tuxedo Lemon” and caused the rider to be unseated. The stewards disqualified #4 “Smart Broad” from 4th position and placed that horse last for interference. New order of finish 2.6.4.5

June 14, 2022 – Race 2

Stewards inquiry and jockey’s objection by the #4 “Boldlee” (Jeremias Flores) against #6 “Special Story” (Steven Fret) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 6.4.7.3

June 15, 2022 – Race 5

Stewards inquiry and jockey’s objection by the #5 “Interstate” (Rudy Ignacio) against #3 “Bijemini Slew” (Benjamin Hernandez) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the contact between the two horses was mutual and did not affect the outcome of the race, the race was made official as is. 3.5.4.6

June 15, 2022 – Race 8

Stewards inquiry and jockey’s objection by the #7 “Mercedes Joe” (Jacqueline Davis) against #4 “Napoleon Complex” (Rudy Ignacio) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the interference did affect the outcome of the race and disqualified #4 “Napoleon Complex” from 3rd position and placed 4th behind #7 “Mercedes Joe.” New order of finish 3.1.7.4

Week 6/20 – 6/25

June 21, 2022 – Race 1

Stewards inquiry and jockey's objection by the #6 "Simply" (Kevin Navarro) against #2 "Daddy Knows" (Andre Worrie) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #2 "Daddy Knows" from 1st position and placed 3rd behind #6 "Simply."
New order of finish 3.6.2.1

June 21, 2022 – Race 3

Stewards inquiry regarding the fall of rider #2 "Call Me Carmelita" (John Berrios) in the stretch. After reviewing the video the stewards determined the #2 "Call Me Carmelita" clipped heels with #4 "Lune Lake" (John Davila, Jr.) and unseated jockey John Berrios. The stewards felt the incident did not warrant and disqualification and made the race official as is. 4.6.3.5

Week 6/27 – 7/2

Nothing to report.

Week 7/4 – 7/9

July 4, 2022 – Race 1

Jockey's objection by the #4 "Color Chart" (Oscar Gomez) against #2 "Gone and Forgotten" (Luis Perez) for possible interference in the vicinity of the 1/8th pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 2.4.5.1

July 5, 2022 – Race 5

Stewards inquiry and jockey's objection by the #2 "True Gold" (Oscar Gomez) against #1 "Two Step Slew" (Luis Perez) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 1.2.1A.3

Week 7/11 – 7/16*July 12, 2022 – Race 1*

Jockey's objection by the #2 "Gusty Wind" (Rudy Ignacio) against #3 "Take Your Place" (Jose Baez) for possible interference in the vicinity of the 1/8th pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 6.5.4.3

July 12, 2022 – Race 7

Stewards inquiry into the fall of rider #1 "Just Stay Home" (Jacqueline Davis) in the vicinity of the ¾ pole. After reviewing the video, the stewards determined the horse "Just Stay Home" caused its own issues unseating the jockey and made the race official as is. 4.2.6.3

July 13, 2022 – Race 9

Stewards inquiry into an incident in the vicinity of the ¼ pole involving the #1 "Big Georges Kingdom" (Luis Perez) and #6 "Achilles Heel" (Andre Worrie). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 4.3.11.6

Week 7/18 – 7/23*July 19, 2022 – Race 2*

Jockey's objection by the #4 "Take Chargechristy" (Kevin Navarro) against #1 "Uno" (Keiber Coa) going into the first turn. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 3.1.4.5

Week 7/25 – 7/30*July 25, 2022 – Race 1*

Jockey's objection by the #3 "Pave My Way" (Kevin Navarro) against #2 "Missing Fortune" (Andre Worrie) for possible interference in the vicinity of the ¼ pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 2.1.3.4

July 25, 2022 – Race 8

Stewards inquiry and jockey's objection by the #8 "Eros's Girl" (Kevin Navarro) against #1 "Galaxina" (Dylan Davis) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 1.8.2.6

July 26, 2022 – Race 6

Stewards inquiry into start regarding #7 "Disco Party" (Carlos Camilo). After reviewing the video the stewards determined the horse caused its own issues leaving the gate. Race made official as is. 1A.2.8.4

July 27, 2022 – Race 3

Stewards inquiry into start regarding the #2 "No Lime" (Steven Fret). Horse stumbled at start unseating jockey. Race made official as is. 3.6.7.1

Week 8/1 – 8/6*August 3, 2022 – Race 7*

Stewards inquiry into the first turn involving #4 "Royal Suspect" (John Berrios) and #1 "Marco Island" (Joel Cruz). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 10.5.2.7

Week 8/8 – 8/13

August 8, 2022 – Race 2

Jockey's objection by the #2 "Coach Bahe" (Nazario Alvarado) against #5 "Florida Endeavour" (Andre Worrie) for possible interference going into the first turn. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 5.2.3.1

August 8, 2022 – Race 3

Stewards inquiry involving the #5 "Count On Friends" (Dean Frates) in the vicinity of the 3/8th pole. After reviewing the video, the stewards determined the horse did not interfere with any other horses and made the race official as is. 3.4.1.2

August 8, 2022 – Race 4

Stewards inquiry involving the #1 "Alarming Mission" (Christian Navarro) in the vicinity of the 3/8th pole. Horse bolted heading into turn. After reviewing the video, the stewards determined the horse did not interfere with any other horses and made the race official as is. 4.7.8.3

August 10, 2022 – Race 7

Stewards inquiry regarding the fall of rider #7 "Calescent" (Kevin Navarro) in the vicinity of the ¼ pole. After reviewing the video, the stewards disqualified #3 "R Working Girl" (Jacqueline Davis) from third position and placed that horse last for interference. New order of finish 2.4.1A.1
