Week 7/3 – 7/8

July 4, 2023 – Race 3

Stewards inquiry involving the #3 “Honorable Avenue” (Joel Cruz) and #4 “Reiner” (Jacqueline Davis) for possible interference in the stretch run. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 4.3.2.1

Week 7/10 – 7/15

Nothing to report.

Week 7/17 – 7/7/22

July 17, 2023 – Race 1

Trainer objection by the #2 “Grit and Glory” (Jose Baez) against #1 “Mo Crazy Blues” (Herman Harkie) and #7 “Khozando” (Keiber Coa) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 3.7.5.2

July 17, 2023 – Race 2

Jockey objection by the #3 “Inouaintalkintome” (Carlos Camilo) against #6 “Smart Broad” (Jeremias Flores) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 6.3.4.2

Week 7/24 – 7/29

July 25, 2023 – Race 4

Stewards inquiry into the start involving #6 “Grandma T” (Michael Davila, Jr). After reviewing the video the stewards determined the horse caused its own issues leaving the gate and the made the race official as is. 3.4.5.1

Week 7/31 – 8/4

July 31, 2023 – Race 4

Stewards inquiry and jockey's objection by the #2 "Breaking Stones" (Joel Cruz) against #1 "Forward Motion" (Keiber Coa) for possible interference in the vicinity of the ¼ pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 1.5.2.(6.7)

Week 8/7 – 8-12

Nothing to report.

Week 8/14 – 8/19

August 15, 2023 – Race 2

Stewards inquiry into an incident just after the start of the race. The stewards determined a broken rein on the #6 "Cancelledcaptivity" (Michael Davila, Jr) created interference to the inside horses and caused #1 "Dons Last Call" (Kevin Navarro) to unseat the rider. The stewards made no change to the final order of finish. 5.2.4.3

August 16, 2023 – Race 5

Stewards inquiry and jockey's objection by the #3 "High Tone" (Heman Harkie) against #4 "Ach Du Lieber" (Michael Davila, Jr.) for possible interference at the top of the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 4.3.2.6

Week 8/21 – 8/26

August 21, 2023 – Race 4

Stewards inquiry into the start of the race involving #6 "Sweet Shallots" (Joel Cruz). The stewards determined the horse stumbled at the start unseating the rider and made no change to the final order of finish. 4.1.7.2

August 22, 2023 – Race 1

Stewards inquiry into the start of the race involving #2 "Gonondagan" (Jhovany Paredes). The stewards determined the horse broke awkwardly at the start unseating the rider and made no change to the final order of finish. 1.6.4.5

Week 8/28 – 9/2

August 28, 2023 – Race 7

Stewards inquiry and jockey's objection by the #6 "Matty's Express" (Kevin Navarro) against #2 "Khozando" (Keiber Coa) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified the #2 "Khozando" from 1st position and was placed 3rd behind #6 "Matty's Express."
New order of finish 5.6.2.4

Week 9/4 – 9/9

September 5, 2023 – Race 4

Stewards inquiry and jockey's objection by the #3 "Major Spin" (Heman Harkie) against #1 "All Time Classic" (Kevin Navarro) for possible interference at the start and in the vicinity of the ¼ pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 1.3.4.7

September 6, 2023 – Race 1

Stewards inquiry and jockey's objection by the #4 "Missimpazibleevan" (Joel Cruz) against #1 "Georgie's Ladies" (Luis Perez) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 1.5.4.2

September 6, 2023 – Race 8

Stewards inquiry into the fall of rider of #5 "Sunshine Girl" (Jose Ventura) in the vicinity of the 5/8ths pole. After reviewing the video the stewards determined the horse caused its own issues and made the race official as is. 10.9.3.6

Week 9/11 – 9/16

September 11, 2023 – Race 4

Stewards inquiry and jockeys objections by the #1 "Lucky Mucho Man" (J.M. Rohena) against #4 "Sorpreso" (Carlos Barbosa) and by #5 "Angelic Mission" (Luis Perez) against #7 "Banco Medici" (Jose Ventura), both for possible interference throughout the stretch run. After reviewing the video and speaking to the riders involved, the stewards determined neither incident affected the outcome of the race and made the race official as is. 7.4.1.5

September 13, 2023 – Race 1

Stewards inquiry and jockey's objection by the #5 "Eight Sunset Drive" (Steven Fret) against #2 "Greek Easter" (Heman Harkie) for possible interference in the stretch. After watching the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #2 "Greek Easter" from 1st position and was placed 2nd behind #5 "Eight Sunset Drive."
New order of finish 5.2.6.3

September 13, 2023 – Race 8

Stewards inquiry and jockey's objection by the #3 "Dons Last Call" (Kevin Navarro) against #1 "Barbara's Spirit" (Carlos Barbosa) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #1 "Barbara's Spirit" from 3rd position and was placed 7th behind #3 "Dons Last Call."
New order of finish 2.4.6.7

Week 9/18 – 9/23

September 18, 2023 – Race 4

Jockey's objections by the #1 "Croagh Patrick" (Christian Navarro) and #4 "Ollie Can Dance" (Luis Perez) against #2 "Gold Templar" (Heman Harkie) in the vicinity of the ¼ pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 3.2.4.5

September 18, 2023 – Race 7

Stewards inquiry and jockey's objection by the #8 "God Bless America" (Emanuel De Diego) against #1A "Predicted" (Heman Harkie) for possible interference in the stretch. After watching the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #1A "Predicted" from 1st position and was placed 2nd behind #8 "God Bless America."
New order of finish 8.1A.2.7

September 19, 2023 – Race 5

Stewards inquiry involving the #1 "Who Is Jarett" (Keiber Coa). After reviewing the video, the stewards determined the horse ducked, unseating Jockey Keiber Coa and made the race official as is. 6.4.7.3

September 19, 2023 – Race 7

Stewards inquiry involving the #7 "Tintagel" (Steven Fret). After reviewing the video, the stewards determined the horse broke awkwardly, unseating Jockey Steven Fret and made the race official as is. 9.1.4.8

Week 9/25 – 9/29

September 26, 2023 – Race 4

Stewards inquiry and jockey's objection by the #6 "Devil or Angel" (Luis Perez) against #2 "Massey Hall" (Steven Fret) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 7.4.3.2

September 27, 2023 – Race 7

Stewards inquiry into the start of the race involving #2 "Mandatory Payout" (Joel Cruz). After reviewing the video the stewards determined the horse caused its own issues leaving the starting gate and made the race official as is. 7.8.5.2

10/2 – 10/7

October 2, 2023 – Race 3

Jockey's objection by the #5 "Jackie B Good" (Michael Davila, Jr) against #4 "Bastet" (Heman Harkie) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 4.5.6.7

October 2, 2023 – Race 7

Stewards inquiry and jockey's objection by the #2 "Gone and Forgotten" (Luis Perez) against #4 "Shesascoldasice" (Jacqueline Davis) for possible interference in deep stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 3.8.4.2

October 3, 2023 – Race 1

Jockey's objection by the #6 "Pompous Prince" (Keiber Coa) against #1A "Flowing River" (Jeremias Flores) for possible interference in the vicinity of the ¼ pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 1A.6.3.4

10/9 – 10/14

October 9, 2023 – Race 7

Stewards inquiry into the start of the race, involving #1 “Mommie’s Jewel” (Jose Baez). After reviewing the video, the stewards determined the horse ducked to the inside and unseated Jockey Jose Baez and made the race official as is. 7.2.4.6

October 10, 2023 – Race 3

Jockey’s objection by the #3 “Trisaetum” (Christian Navarro) against #2 “Interstate” (Rafael Rohena, Jr) and #5 “What’s My Category” (Joel Cruz) for possible interference in the vicinity of the ¼ pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 2.5.3.7

10/16 – 10/21

October 17, 2023 – Race 2

Objection by the trainer of the #2 “Deville” (Kevin Navarro) against the #6 “Bustinroxy” (Keiber Coa) at the top of the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 3.6.4.5

10/23 – 10/28

October 23, 2023 – Race 5

Stewards inquiry into the start involving the #3 “Honorable Avenue” (Keiber Coa). After reviewing the video, the stewards determined the horse caused its own issues leaving the gate and made the race official as is. 1.6.4.2

10/30 – 11/4

Nothing to report.

11/6 – 11/11

November 6, 2023 – Race 3

Stewards inquiry into the stretch run, involving the #1 “Central Love” (Michael Davila, Jr.), #3 “Crypto Causeway (Jeremias Flores) and #6 “Ginnsu Warrior” (Christian Navarro). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 6.3.1.4

November 7, 2023 – Race 1

Stewards inquiry into the start of the race, involving #3 “Quiet Horizon” (Heman Harkie). After reviewing the video, the stewards determined the start was compromised and made the horse a non-starter, ran for purse money only. 6.2.1.(3).4

November 7, 2023 – Race 6

Stewards inquiry into the stretch run. After reviewing the video, the stewards determined #12 “Superb Surprise” (Jeremias Flores) tripped and unseated the rider, also causing the #6 “Thirty Oysters” (Carlos Camilo) to fall and unseat its rider. The stewards made the race official as is. 4.11.10.9

11/13 – 11/18

November 14, 2023 – Race 7

Jockey’s objection by the #3 “Tosconova Beauty” (Nazario Alvarado) against #8 “Gone and Forgotten” (Keiber Coa) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. 6.8.1.3

11/20 – 11/25
