

Stewards Corner May 18, 2015 – May 23 2015

Monday May 18 2015 Race 5, Stewards poster an Inquiry and Rudy Ignacio rider of Salute to Summer (#3) claimed foul against Married to Michael (#5) in the stretch. The Stewards reviewed the video and spoke to the riders. The stewards noticed that the 5 horse did drift out and slightly impeded the 3 horse. The Stewards consensus was that it did not change the outcome of the race so the race was made official as is.

Thursday May 21, 2015 4th race the stewards posted a Inquiry stumbled at start unseated rider. No action taken.

Friday May 22, 2015 9th race Jockey Jose M. Rivera rider of Hellcat (#3) claimed foul on Absolute Paradise (#2) at the ½ mile pole. After reviewing the video and speaking to the riders the consensus of the Stewards was to make the race official as is.

Steward's Corner May 25.2015 to May 29, 2015

Monday May 25, 2015

Race 2: Jockey Louis Perez, rider of "Pleasures All Wine" (#3) claimed foul against "Destiny's Mystery" (#5) Jockey Perez's horse clipped heels with the 5 horse going into the 1st turn. After reviewing the video and speaking with the Jockeys the Stewards decided that "Pleasures All Wine" drifted out entering the turn and clipped the heels of "Destiny's Mystery" causing his own problem. Therefore the Stewards consensus was to make the race official as is.

Race 3: Stewards Posted Inquiry into the start of the race; "L. C. Sleepy" (#6) reared at the start and "Run Jack Run" (#2) Stumbled at the start. The consensus of the Stewards was that the horses made their problems and therefore the race was made official as is.

Stewards corner Week ending June 7, 2015

Monday June 1, 2015 8th Race; Stewards posted an Inquiry into the stretch run and Jockey Joel Cruz, rider of "Wiseman Jack" (#9) claimed foul against "Power Dreams" (#6) ridden by Kevin Roman in the area of the 1/16th pole. "Power Dreams" drifts in and causes "Wiseman Jack" to check. After Reviewing the video and speaking to the Riders the consensus of the stewards was to disqualify "Power Dreams" and to place that horse 3rd behind "Power Dreams". The race was then made Official.

Tuesday June 2, 2015 1st Race; Jockey J. M. Rohena rider of "Imposing Figure" (#1) Claimed foul against "Shifty's Stardust" (#3) ridden by jockey Michael A. Davila in the stretch during the running of the 1st race. Jockey Rohena stated that the 3 horse drifted in and interfered with his horse. After viewing the video and speaking to the riders the Stewards Decided to make the race official as is.

Thursday June 4, 2015; 6th Race Stewards Inquiry "Hughes Next" (#8); ridden by Jockey Jaime Rodriguez, broke his left Fore leg in the area of the 1/16th pole. "Backstage Pass" (#3) shied away from the #8 and unseated his rider Oscar Gomez. After reviewing the video the stewards found no reason for any change in the order of finish.

Stewards Corner Week ending June 14, 2015

Monday June 8, 2015; First Race Stewards Inquiry and an objection filed by Jockey Emanuel De Diego rider of " Mecke Mantle" (#3) against "Kitchi Warrior" (#2) ridden by Jockey Oscar Gomez. De Diego stated that "Kitchi Warrior" came out and bothered him just before the wire. After reviewing the video and consulting with the riders the Steward unanimously decided to make the race official and hold a review of the race the following race day to decide if any further action was needed.

Friday June 12. 2015; First race Stewards Inquiry, "Pete's Fleet" (#1) ridden by jockey J. M. Rohena Tried to jump The rail as it came on to the main track from the six furlong chute unseating Jockey Rohena. After review of the video the Stewards made the race official as is.

Stewards Corner Week ending June 21, 2015

Tuesday June 16, 2015; Fourth Race, Jockey Luis E. Perez rider of "Royal Silk" (#2) claimed foul stating that his horse was struck in the nose with the whip in the stretch by Jockey Pedro A. Rodriguez rider of "Stoney Freud" (#7). After reviewing the video and speaking to the riders the Stewards could not see any evidence of the horse being struck. Therefore the race was made official as is.

Thursday June 18, 2015; Second Race, the Stewards Posted an Inquiry and Jockey Jaime Rodriguez rider of "G.K.'s Miracle" (#2) Claimed foul against "Bond Baroness" (#6) in the stretch. The video shows "Bond Baroness" drifting out in the stretch and pushing "G K's Miracle" out. The Stewards consensus was to disqualify "Bond Baroness" fro second position and placed third for interfering with "G K's Miracle".

Thursday June 18, 2015; Eighth Race, Jockey Wilfredo Rohena rider of "Meet the Mets" (#7) Claimed foul on "Dancer's Rocket" (#2) for interference in the stretch. After reviewing the video and speaking with the riders the stewards found no reason for a disqualification and made the race official as is.

Friday June 19,2015; 9th Race, Stewards Inquiry into the start. "B. E. Isabella" (#3) reared at start. After reviewing the video the Stewards found no reason to take any action and the race was made official.

Saturday June 20, 2015; 4th race, Stewards Inquiry into the stretch run. Stewards noticed incidental touching between "Fightin Irish" (#1) and "Electric Currency" (#7). After reviewing the video and talking to the riders it the result was made official as is.

Stewards Corner week ending June 28,2015

Monday June 22, 2015; 1st Race, Jockey Gray Wales rider of "Father Dennis" (#4) claimed foul against "Summer Brother" (#3) ridden by Jockey Pedro A. Rodriguez for alleged interference in the stretch. After reviewing the video and speaking to the riders the Stewards decided to make the race official as is.

Monday June 22, 2015; 5th Race, The Stewards posted an Inquiry into the start of the race. "Why Seventeen" (#6) Was in the hands of the Assistant Starter and failed to have a fair start. He was declared a nonstarter for Pari-Mutuel purposes.

Thursday June 25, 2015; 9th Race, Guillermo Rodriguez rider of Red Roma (#3) claimed foul against Patriot Star (#9) ridden by David Michael Lopez in the area of the 5/16th pole claiming that the 9 horse came over and interfered with him. After reviewing the video and speaking to the riders the consensus of the Stewards was that the incident had no effect on the outcome of the race. Therefore the race was made official as is.

Stewards Corner Week Ending July 5, 2015

Saturday July 4, 2015; Third race, Jockey Jason Simpson rider of "Keen On Green" (#4) claimed foul against "Little Gabby Girl" (#3) ridden by Wilfredo Rohena in the area of the 16th pole. After reviewing the video and talking to the riders the consensus of the Stewards was no action should be taken, Therefore the race was made official as is.

Stewards Corner Week Ending July 11, 2015

Monday, July 6, 2015; Fifth race, Stewards inquiry, "Katmai Unleashed" (#5) broke down in the area of the 5/16ths pole. Stewards ordered the finish of the race as is.

Tuesday, July 7, 2015; Fifth race, Stewards inquiry into start, "Sir Dream a Lot" refused to start. After reviewing the video the consensus of the Stewards was the start was not compromised and ordered no change.

Stewards Corner July 13, 2015 to July 18, 2015

Monday July 13, 2015; Fourth Race, Trainer of "Seriously Sharp" (#5) James Kettle claimed foul against "Awesome Lute" (#8) in the area of the 1/16 pole. After reviewing the video and speaking to the riders the Stewards consensus was that there was no reason for any change in the order of finish and the race was made official.

Tuesday July 14, 2015; First Race, Stewards Posted an Inquiry into the stretch run, "National Buck" (#4) ridden by Jockey Jeremias Flores drifts out in the last 1/16th of a mile and impedes "Party On" (#5) which was beaten by a neck. After reviewing the video and speaking to the Jockeys The stewards decided to disqualify "National Buck" from first position and place him second.

Thursday July 16, 2015; Second Race, Jockey Guillermo Rodriguez rider of "Unbridled Band" (#4) claimed foul on "Chasin Chama" (#2) ridden by Jockey Oscar Gomez in the area of the 1/16 pole during the running of the 2nd race after reviewing the video and speaking to the riders the consensus of the Stewards was to disqualify "Chasin Chama", for drifting out and impeding "Unbridled Band, from second position and place that horse third.

Thursday July 16, 2015; Fourth Race, The Stewards posted the Inquiry and Oscar Gomez, rider of "Miz Sweet" (#4) claimed foul against "Rose of Sicily" (#2) in the area of the 1/16th pole during the running of the 4th race. After reviewing the video and speaking to the riders the stewards decided to disqualify "Rose of Sicily" for drifting in on "Miz Sweet" from fifth position and placed sixth.

Friday July 17, 2015; 9th Race, Jockey Gabriel Suarez rider of "Golden Nugget" (#6) claimed foul against "Roar of Raul" (#2) in the area of the ¼ pole. After reviewing the video and speaking to the Jockeys the Stewards noting that the video which could be seen was inconclusive and made the race official as is.

Stewards Corner week of Monday July 20 to Saturday July 25 2015

Monday July 20 2015, Fifth Race Jockey Rudy Ignacio rider of Wild Hardships (#3) claimed foul against "Essence at Noon" (#1) and "Meetinghouse Road" (#2) at the start. After reviewing the video and speaking to the riders the Stewards made the official as is.

Stewards Corner Week ending August 8 2015

Monday August 3, 2015, Sixth Race The Stewards Posted an Inquiry into the start of the race. After review of the video tapes and speaking to the Starter the Stewards declared #3 "Estimator" and nonstarter for pari-mutuel purposes. The horse had its nose behind the bar of the starting gate and did not get a fair start.

Thursday August 6, 2015, Sixth Race Jockey Joel Cruz rider of "French Wine" (#1) claimed foul against "Indy Tune" (#6) in the stretch during the running of the 6th. After reviewing the video and talking to riders the race was made official as is.

Thursday August 6, 2015, Ninth Race. Jockey Jaime Rodriguez rider of "Senora de Lolo" (#8) claimed foul against "Morning Headache" (#6) ridden by Jockey Wilfredo Rohena and "Spotlights Fortune" (#7) in the stretch. After reviewing the video and speaking to the riders the race was made official as is.

Saturday August 8 2015, Second Race The Stewards posted an Inquiry into the start and Jockey Jason Simpson rider of "Splendid Charlie" (#9) claimed foul against "Eltry" (#2) in the stretch. After reviewing the video and speaking to the riders the race was made official as is.

Steward's Corner Week ending Saturday August 15 2015

Monday August 10, 2015 Seventh race The Stewards posted an Inquiry into the start. "Piano Star" (#7) ridden by Jockey Rafael Rohena Broke Awkwardly from the gate and the rider lost his Irons. After reviewing the video the Stewards made the race official as is.

Friday August 14, 2015 Sixth Race; Jockey Gabriel Suarez rider of "Im Mr. Right" (#2) claimed foul against "Readyfortheday" (#7) in the area of the 3/8th Pole. After reviewing the video and speaking to the riders the Stewards made the race official as is.

Stewards Corner Week ending August 22 2015

Thursday August 20 2015 First Race; Mondor (#1) ridden by Jockey Oscar Gomez Broke down in the area of the ¼ pole and was euthanized on the track. Stewards Inquiry found no reason for any change and made the race official as is.

Friday August 21 2015, 3rd race; Stewards posted an Inquiry into the Start. "Distorted Dream" (#1) turned his head at the start of the race and got off poorly. The Stewards found no reason for a change and made the race official as is.

Saturday August 22 2015, 5th race; Stewards posted an inquiry and Guillermo Rodriguez rider of "Readyforthe day" (#4) Claimed foul against "I'll do it myself" (#7) For pushing the 4 horse to the outside in the stretch. The Stewards disqualified the 7 horse and placed that horse fifth.

Monday August 24 2015, First Race Stewards inquiry into the start, "Comity" (#1) reared at the start, the Stewards found no reason for a change and made the race official as is.

Tuesday August 26, 2015, Ninth Race Stewards posted an Inquiry into the stretch run. Apprentice Jockey Carlos Camillo, Jr. rider of "Coach Germ" (#2) lost his balance while using his whip and fell off. The race was made official as is.

Monday August 31, 2015 fifth race the rider of "My Bobby" (#6) Jockey Luis E. Perez claimed foul on (#11) "E Z Eddie" on the turn. After reviewing the video and speaking to the Riders the Stewards decided to disqualify "E Z Eddie" and place that horse 3rd behind "My Bobbie".

Friday September 4, 2015 first race, the rider of "Southbeachsandy" (#1) Jockey Rudy Ignacio claimed foul on (#2) "Western Tryst" ridden by Jamie Rodriguez, in the area of the ½ mile pole. After reviewing the video and speaking to the riders involved the stewards decided there would be no change to the order of finish.

Stewards Corner week of Sept.7, 2015 through Sept. 12, 2015

Monday Sept. 7, First 2015 Jockey Wilfredo Rohena rider of "Kleptocrat" (#1) claimed foul against "Abounding Spirit" (#2) shortly after the start of the first race. After reviewing the video and speaking to the riders the Stewards found no reason to for any change and made the race official.

Tuesday Sept. 8, 2015 9th race Stewards posted an inquiry and the Trainer of "Wabash River" (#3) Ortis Henry claimed foul against "Skeddletoseattle" (#6) ridden by David Michael Lopez. After reviewing the video and speaking to the riders the Stewards found no reason for a disqualification and made the race official as is.

Thursday Sept. 10, 2015 4th race Jockey Rudy Ignacio rider of "Space Cowboy" (#7) claimed foul against "Backtothesaltmine" (#2) ridden by jockey in the stretch. After reviewing the video and speaking to the riders the stewards made the race official as is.

Thursday Sept.17, 2015 5th race Luis E. Perez rider of "Here We Go Joe" (#1) claimed foul against "French Wine" (#5) in the stretch. After reviewing the video and speaking to the riders the Stewards made the race official as is.

After reviewing the video and speaking to the riders the Stewards made the race official as is.

Saturday Oct 17, 2015 2nd Race The Stewards posted an inquiry. "Silk Spinner" (#6) Dwelt in the Starting Gate. Stewards made the race official as is after reviewing the video.

Saturday Oct. 17,2015 5th Race The Stewards posted an inquiry because "Sky Devil" (#6) broke down at the 1/8th Pole. The Stewards made the race official after reviewing the video.

Saturday Oct. 17, 2015 6th Race The Stewards posted an Inquiry into the Stretch run "Big Bug" (#6) ridden by Jockey Jamie Rodriguez ,interfered with "Catch Me Ha Ha" (#4). After reviewing the Video and speaking to the riders "Big Bug" was disqualified from 2nd position and placed 3rd.

Monday Oct. 19 2015, 2nd Race Stewards posted an Inquiry into the stretch run due to the fact "Splendid Charlie" bolt towards the outside rail. After reviewing the video the Stewards made the race official as is.

Tuesday, October 20, 2015, 9th race Stewards inquiry into start, #8 "Jersey Frere" broke poorly. After reviewing the video the Stewards felt the horse caused its own problems leaving the gate and made the race official as is.

Thursday, October 22, 2015 6th race Stewards posted an Inquiry into the start. Gate door on number 5 stall did not function properly the Stewards declared "Jackie Black" (#5) a nonstarter for betting purposes, refunding all bets.
