Saturday April 29, 2017; 5th Race Jockey Luis E. Perez rider of "Dremas Boy" (#5) claimed foul against "Bedside Blues" (#4) at the head of the stretch. After reviewing the video and speaking to the riders, the Stewards made the race official as is. A review of the video was scheduled for Monday May 1st.

May 6, 2017 Third Race; an Inquiry was posted into the Start. "Alcanudance" (#4) The assistant starter had a hold of the horse after the start. "Alcanudance" was declared a nonstarter for wagering purposes.
