

## STEWARDS CORNER 2025

### **Week 4/28 – 5/3**

*April 29, 2025 – Race 8*

Stewards inquiry into the fall of rider , #7 One Witheverything (J. Berrios), in the vicinity of the ½ mile pole. After reviewing the video the stewards determined #4 Frontal Vision (J. Diaz), drifted out slighting causing the #7 to clip heels and lose its rider. #4 Frontal Vision was disqualified from 4<sup>th</sup> position and placed last. New Order of finish 3.1.8.6

### **Week 5/5 – 5/10**

Nothing to report.

### **Week 5/12 – 5/17**

*May 12, 2025 – Race 8*

Stewards inquiry and jockey objections by the #4 Solvency (E. DeDiego) and #3 Montauk Memoirs (J. Flores) against #5 Swift Bank (J. Baez) into an incident in the vicinity of the 4 ½ furlong pole. A separate inquiry was also posted into the fall of rider #6 Run With Honor. After reviewing all video and speaking to the riders, the stewards ordered no change. Order of finish 5.1.3.2

### **Week 5/26 – 5/31**

*May 28, 2025 – Race 2*

Stewards inquiry and trainer's objection by the #6 Reiterate (J. Berrios) against #7 Investment Grade (C. Camilo) for possible interference in the stretch. After reviewing the video and speaking to the riders involved the stewards ordered no change. Final order of finish 1.7.6.4

**Week 6/2 – 6/7**

*June 2, 2025 – Race 5*

Stewards inquiry into the fall of rider , #7 Reason to Risk (J. Davis), in the vicinity of the 5/8<sup>th</sup> pole. After reviewing the video the stewards determined #9 Miss C Banker (K. Coa) came down causing the #7 to clip heels and lose its rider. #9 Miss C Banker was disqualified from 1<sup>st</sup> position and placed last. New Order of finish 11.1.3.12

**Week 6/9 – 6/14**

*June 9, 2025 – Race 3*

Stewards inquiry into the start involving #4 Interchanger (J. Baez). After reviewing the video the stewards determined the horse caused its own issues leaving the gate and made the race official as is. 5.3.6.4

**Week 6/16 – 6/21**

*June 16, 2025 – Race 4*

Stewards inquiry into the start, involving the fall of rider of #3 Coin Jar (K. Navarro). After reviewing the video the stewards determined the horse caused its own issues leaving the gate and made the race official as is. Final order of finish 6.1.4.2

*June 17, 2025 – Race 7*

Stewards inquiry into the start involving #2 Princess Cairo (J.M. Rohena). After reviewing the video the stewards determined the horse reared at the start and made the race official as is. Final order of finish 5.6.7.8

*June 18, 2025 – Race 2*

Stewards inquiry and jockey's objection by the #6 Revivalism (K. Navarro) against #3 Enticing Prospect (K. Coa) for possible interference in the stretch. After reviewing the video and speaking to the riders involved the stewards ordered no change. Final order of finish 3.6.1.4

**Week 7/7 – 7/12**

*July 8, 2025 – Race 3*

Stewards reviewed the start of #6 Mambagigi (A. Worrie) and determined the horse hopped at the start, just as the gates opened. All stalls opened at the signal as the starter. Final order of finish 6.5.2.3

*July 9, 2025 – Race 6*

Steward inquiry into the stretch run, involving #4 Don Antonio (C. Camilo) and #5 Frankie R. (J. Cruz). After reviewing the video and speaking to the riders involved, the stewards determined both horses made contact and ordered no change. Final order of finish 4.5.3.2

**Week 7/14 – 7/19**

*July 14, 2025 – Race 8*

Stewards inquiry into the start, involving #1 Jak N Burny (J. Cruz). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 1.9.7.3

*July 15, 2025 – Race 7*

Stewards inquiry and jockeys objection by the #1 New Matthew (L. Perez) against #3 Mr. Ripple (K. Coa) for possible interference just after the start. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 3.4.6.7

**Week 7/21 – 7/26**

*July 22, 2025 – Race 5*

Stewards inquiry and jockey's objection by the #2 Makar (A. Worrie) against #1 Neptune Beach (Y. Cintron) for possible interference in the vicinity of the 3/8ths pole and through the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 1.2.5.4

*July 23, 2025 – Race 3*

Stewards inquiry into the start and fall of rider of #2 Eddie Marie (K. Navarro). After reviewing the video, the stewards determined the horses' start was compromised and made the horse a non-starter. Final order of finish 1.6.5.4

*July 23, 2025 – Race 5*

Stewards inquiry into the start of #2 Can't Stand Disco (J. Cruz). After reviewing the video, the stewards determined the horse reared at the start unseating the jockey. Final order of finish 5.3.4.6

*July 23, 2025 – Race 6*

Stewards inquiry into the start and fall of rider of #1 In A Minute (J. Baez). After reviewing the video, the stewards determined the horse stumbled at the start unseating the jockey. Final order of finish 7.5.3.2

**Week 7/27 – 8/2**

*July 28, 2025 – August 6*

Stewards inquiry involving #5 Gonna Be Possible (N. Alvarado) for an incident in the turn. After reviewing the video, the stewards determined the horse bolted in the turn and made the race official as is. Final order of finish 6.2.4.7

## **Week 8/4 – 8/9**

### *August 4, 2025 – Race 3*

Stewards inquiry and jockeys objection by the #3 Apollo Code (J. Flores) against #6 Coin Jar (J. Baez) for possible interference in the vicinity of the 5/8<sup>th</sup> pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 6.3.2.5

### *August 5, 2025 – Race 2*

Stewards inquiry into an incident going into the first turn, involving the #2 El Bombi (J. Baez) and #3 Tip of the Boot (J. Berrios). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 5.3.1.2

### *August 5, 2025 – Race 7*

Jockey objection by the #5 Sea Shepherd (C. Elliott) against #2 Holy Dancer (J. Cruz) for possible interference at the top of the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 4.2.5.3

### *August 6, 2025 – Race 4*

Stewards inquiry and jockeys objection by the #4 Shock (A. Worrie) against #2 Dharma (C. Navarro) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #2 Dharma from 1<sup>st</sup> position and placed 2<sup>nd</sup> behind #4 Shock.

### *August 6, 2025 – Race 7*

Stewards inquiry and jockeys objection by the #4 Warriors Revenge (K. Navarro) against #5 Forty Two Ace (A. Worrie) for possible interference in the vicinity of the ¼ pole. A second claim of foul was lodged by #6 No Confession (C. Russell) against #7 Breaking Stones (J. Flores) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incidents did not affect the outcome of the race and made the race official as is. Final order of finish 7.5.62

**Week 8/11 – 8/16***August 11, 2025 – Race 1*

Stewards inquiry and jockey's objection by the #4 Seams Like Destiny (H. Harkie) against #2 Janssen (M. Davila) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #2 Janssen from 2<sup>nd</sup> position and was placed 3<sup>rd</sup> behind #4 Seams Like Destiny. New order of finish 1.4.2.5

*August 11, 2025 – Race 5*

Stewards inquiry into the start involving #10 Iron Man Ira (E. DeDiego). Stewards determined the horse stumbled at the start and unseated the jockey. Final order of finish 2.8.9.5

*August 13, 2025 – Race 8*

Stewards inquiry into the start involving #4 Chukatuck (C. Navarro). Stewards determined the horse stumbled at the start and unseated the jockey. Final order of finish 3.7.2.1

**Week 8/18 – 8/23***August 18, 2025 – Race 1*

Jockey objection by the #1 Charlie's Express (C. Elliott) against #5 Newport Bridge (J. Cruz) for possible interference up the backstretch. After reviewing the video and speaking to the riders involved the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 5.1.2.4

*August 19, 2025 – Race 5*

Stewards inquiry into an incident involving #6 Majestic Michael (R. Gutierrez) in the vicinity of the ¼ pole. After reviewing the video the stewards determined the horse bolted and was pulled up. Final order of finish 4.1.7.3

**Week 8/25 – 8/30***August 27, 2025 – Race 8*

Stewards inquiry and jockey's objection by the #8 Love Thyself (J. Baez) against #5 True Destiny (K. Coa) and #6 Mind of Gold (C. Navarro) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #5 True Destiny from 2<sup>nd</sup> position and was placed 3<sup>rd</sup> behind #8 Love Thyself. New order of finish 6.8.5.4

## **Week 9/1 – 9/6**

### *September 2, 2025 – Race 5*

Stewards inquiry and jockey's objection by the #8 Skellig Island (C. Navarro) against #5 Viking Warrior (A. Worrie) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #5 Viking Warrior from 3<sup>rd</sup> position and was placed 4<sup>th</sup> behind #8 Skellig Island. New order of finish 7.9.8.5

### *September 3, 2025 – Race 1*

Stewards inquiry into the start involving #4 Stjames. The horse was pulled up in the vicinity of the 7/8ths pole and race was made official as is. Final order of finish 2.3.5.6

## **Week 9/8-9/13**

### *September 9, 2025 – Race 3*

Stewards inquiry into the stretch run involving #5 Brockmoninoff (J. Flores) and #6 Bustin Pietre (A. Worrie) for possible interference in the stretch. After speaking reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 1a.4.6.5

### *September 9, 2025 – Race 7*

Stewards inquiry into the start involving #5 Gray Haired Gus (K. Navarro). Stewards determined the horse reared at the start and unseated the jockey. Final order of finish 8.2.6.3

### *September 10, 2025 – Race 2*

Stewards inquiry and jockey's objection by the #3 Crystal (Y. Cintron) against #2 E Complcato (M. Davila) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #2 E Complicato from 1<sup>st</sup> position and was placed 4<sup>th</sup> behind #3 Crystal. New order of finish 7.1.3.2

**Week 9/15 – 9/20**

*September 15, 2025 – Race 6*

Stewards inquiry and jockey's objection by the #7 Love Thyself (J. Baez) against #6 Seattle Causeway (C. Navarro) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified the #6 Seattle Causeway from 2<sup>nd</sup> position and was placed 3<sup>rd</sup> behind #7 Love Thyself. New order of finish 5.7.6.3

*September 17, 2025 – Race 2*

Stewards inquiry and jockey's objection by the #3 Bourbon Blanket (J. Flores) against #6 Candy is Dandy (H. Harkie) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified the #6 Candy is Dandy from 2<sup>nd</sup> position and was placed 3<sup>rd</sup> behind #3 Bourbon Blanket (J. Flores). New order of finish 4.3.6.2

**Week 9/22 – 9/27**

*September 24, 2025 – Race 4*

Stewards inquiry in the start and fall of rider of #5 Interchanger (O. Gomez). After reviewing the video the stewards determined the horse broke awkwardly and made the race official as is. Final order of finish 9.3.4.6

**Week 10/6 – 10/11**

*October 7, 2025 – Race 9*

Stewards inquiry and jockey's objection by the #8 Ex Machina (K. Coa) against #9 Ry's Advantage (O. Gomez) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #9 Ry's Advantage from 1<sup>st</sup> position and was placed 4<sup>th</sup> behind #8 Ex Machina. New order of finish 6.3.8.9

**Week 10/13 – 10/18**

*October 14, 2025 – Race 4*

Stewards inquiry into the stretch run, involving #2 Manny Penny (J. Cruz) and #8 Wine Responsibly (R. Rohena Jr). After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 1.2.8.5

*October 14, 2025 – Race 6*

Stewards inquiry and jockey's objection by the #8 Ace Up Her Sleeve (R. Gutierrez) against #4 Practical Rachel (O. Gomez) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified the #4 Practical Rachel from 1<sup>st</sup> position and was placed 4<sup>th</sup> behind #8 Ace Up Her Sleeve. New order of finish 7.1.8.4

**Week 10/20 – 10/25**

*October 20, 2025 – Race 5*

Stewards inquiry into the fall of rider of #6 Book of Wisdom (R. Maragh). After reviewing the video and speaking to the riders involved, the stewards determined the #3 She's Grand (L. Perez) drifted out, causing the #6 Book of Wisdom to clip heels with #8 Play Good Pay Good and unseated the rider. The stewards disqualified #3 She's Grand from 6<sup>th</sup> position to last. New order of finish 9.8.2.5

**Week 10/27 – 11/1**

*October 29, 2025 – Race 8*

Jockey's objection by the #4 Utamaro (L. Pena) against the #1 Big Rich (A. Worrie) and #5 Gandy Dancing (J. Ventura) for possible interference going into the first turn. After reviewing the video and speaking to the riders involved, the stewards disallowed the objection and made the race official as is. Final order of finish 1.4.6.8

## **Week 11/3 – 11/8**

*November 3, 2025 – Race 2*

Stewards inquiry and jockey's objection by the #8 Lookin' Super (C. Russell) against #1 Khali's Dream (JM Rohena) for interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified the #1 Khali's Dream from 1<sup>st</sup> position and was placed 2<sup>nd</sup> behind #8 Lookin' Super. New order of finish 8.1.4.5

*November 4, 2025 – Race 5*

Stewards inquiry into the start involving #2 Tumbles (L. Pena). After reviewing the video and speaking to the starting gate crew, it was determined the horse caused its own problems leaving the starting gate and the race was made official as is. Final order of finish 4.1.5.6

## **Week 11/10 – 11/15**

*November 10, 2025 – Race 1*

Jockey's objection by the #4 Stormy's Dreaming (L. Perez) against #8 Bonne Chance (H. Harkie) for possible interference in the vicinity of the 3/8ths pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 8.4.3.7

*November 12, 2025 – Race 3*

Stewards inquiry and jockey's objection by the #5 Barfly (A. Worrie) against #1 Dorothys Happiness (J. Flores) for possible interference in the vicinity of the ¼ pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 1.2.5.7

*November 12, 2025 – Race 5*

Jockey's objection by the #3 Scarlett Queen (L. Pena) against #1 Galileans Girl (N. Alvarado) for possible interference in the vicinity of the 5/8ths pole.

*November 13, 2025 – Race 3*

Jockey's objection by the #6 Eddie Marie (K. Navarro) against #5 Bam's Bliss Kiss (N. Alvarado) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 5.6.4.2

*November 13, 2025 – Race 7*

Stewards inquiry into the stretch run involving #5 Scoot Daddy (L. Perez) and #6 Play (R. Gutierrez) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 6.5.2.3

After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 2.1.5.6

*November 24, 2025 – Race 2*

Stewards inquiry and jockey's objection by the #2 Phonecalltoheaven (K. Coa) against #1 Red Butterfly (C. Navarro) and #5 Eastern Star (J. Flores) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #1 Red Butterfly from 2<sup>nd</sup> position and was placed 5<sup>th</sup> behind #2 Phonecalltoheaven. New order of finish 5.4.3.2

*November 24, 2025 – Race 3*

Stewards inquiry and jockey's objection by the #5 Enticing Prospect (K. Coa) against #4 Nilruc (R. Gutierrez) for possible interference in the stretch. After reviewing the video and speaking to the riders involved, the stewards determined the incident did affect the outcome of the race and disqualified #4 Nilruc from 1<sup>st</sup> position and was placed 4<sup>th</sup> behind #5 Enticing Prospect. New order of finish 7.6.5.4

*November 24, 2025 – Race 9*

Jockeys objection by the #4 Profitability (J. Cruz) against #9 Burning Munny (N. Alvarado) for possibly interference in the vicinity of the 3/16ths pole. After reviewing the video and speaking to the riders involved, the stewards determined the incident did not affect the outcome of the race and made the race official as is. Final order of finish 9.6.4.8

*November 25, 2025 – Race 3*

Stewards inquiry into the start involving #3 Mr. Einstein (E. DeDiego). After reviewing the video the steward determined the horse reared at the start and made the race official as is. Final order of finish 5.6.1.2

*November 26, 2025 – Race 9*

Stewards inquiry into the start involving #1 Crews in to Win (J. Diaz). After reviewing the video the stewards determined the horse stumbled at the start unseating the rider and made the race official as is. Final order of finish 9.4.5.8
