Method of Entry:** During the Entry Earning period above, members of Finger Lakes’ Ember Rewards may earn official entries with each base point earned by playing any Finger Lakes video gaming machine with their own Ember Rewards card actively inserted. Each member’s first entry on any entry-activation day – October 3, 10, 17, 24, 31, 2026 -- is earned by reaching a threshold of \$5 bet with their Ember Rewards card inserted. Tiered card entry multipliers will apply daily. Additionally, all members are eligible for 2x entry multiplier on

Tuesdays occurring within the promotional period. Final eligibility for cash drawings requires entry activation, as described below.

6. Cash Drawings / Prizes:
